- 1.1. At the Time of Admission: Students must pay the Admission Fee along with 1st and 2nd Semester fees together at the time of admission. This is mandatory for confirmation of admission.
- 1.2. Subsequent Semesters: Fees for each semester (3rd, 4th, 5th, 6th, 7th, 8th) must be paid in full before the commencement of that respective semester.
- 1.3. Due Date: Semester fees must be submitted before the start of each semester. For example, 3rd Semester fees must be paid before 3rd Semester classes begin (i.e., after completion of 2nd Semester).

2. Late Payment Penalty

- 2.1. If fees are not paid by the due date, a penalty will be charged at the rate of 8% per annum or ₹50 per day, whichever is applicable as determined by the College Management Committee (CMC).
- 2.2. Students who fail to pay fees on time may be denied attendance in classes and clinical training until payment is completed.

3. Fee Inclusions

- 3.1. The above fee structure is all-inclusive and covers the following:
 - Tuition Fees
 - Admission Fees
 - Library Access
 - Laboratory Facilities
 - Hospital Clinical Experience
 - Campus Amenities and Utilities
 - All Academic and Administrative Charges
- 3.2. No Hidden Charges: There are no additional or hidden charges within the campus for the services mentioned above.

4. External/Excluded Fees

- 4.1. The following fees are excluded from the above structure and will be charged separately as applicable:
 - University/Board Examination Fees (as per Tripura Nursing Council or affiliating university norms)
 - Hostel Fees (if availed)
 - Transport Fees (if availed)
 - Uniform and Books (if purchased from college)
 - Any other external fees mandated by regulatory authorities or government bodies

5. Scholarships and Discounts

- 5.1. Admission-Time Discount (Based on 12th Board Examination and Oral Questionnaire)

Students may be eligible for a one-time discount on the full course fee at the time of admission based solely on their 12th Board Examination percentage and performance in an oral questionnaire conducted during admission. The parameters for granting this discount will be decided by the College Management Committee (CMC) and include:

- Percentage marks obtained in the 12th board exams.
- The candidate's responses and overall performance during the oral questionnaire.
- Official mark sheets and certificates submitted by the student will be considered valid proof.
- This discount is applied once at the time of admission as a reduction on the full course fee. No further discounts aside from this and any on-time payment discount will be offered by the college.

5.2. One-Time Full Course Payment Discount

Students who pay the entire course fee in one installment at the time of admission will receive an additional 2% discount on the total course fee (After deduction of Clause 5.1).

6. Fee Refund and Withdrawal

- 6.1. Fees once paid are non-refundable and non-transferable except in cases mentioned under scholarship/discount refund provisions (if any).
- 6.2. In case of withdrawal or discontinuation from the course, the fees paid will not be refunded, and the student may be liable for additional administrative charges as per the college policy.

7. Payment Modes

- 7.1. All fee payments must be made through the following authorized modes only:
 - Bank Demand Draft (DD) in favor of "Pranav Paramedical & Nursing College"
 - Online Bank Transfer (NEFT/RTGS/IMPS) to the college's official bank account
 - Online Payment Gateway (as provided on the college website)
 - Cash payment at the college accounts office to authorized officer/accountant only (subject to limits as per regulations)
- 7.2. It is mandatory to obtain an official receipt for all fee payments, especially for cash payments.
- 7.3. Students must retain official fee payment receipts for verification purposes.

9. Fee Revision

- 9.1. The college reserves the right to revise the fee structure for subsequent academic sessions. However, fees for students already admitted will remain unchanged for the duration of their course.
- 9.2. Any changes in fees or terms will be communicated to students and parents in advance through official college notices.

10. Compliance and Responsibilities

- 10.1. The student and parent/guardian are jointly responsible for ensuring timely fee payment as per the schedule.
- 10.2. Failure to comply with the fee payment terms may result in:
 - Denial of attendance in classes and clinical training
 - Withholding of examination hall tickets
 - Suspension or cancellation of admission
- 10.3. All disputes regarding fees or discounts will be subject to the final decision of the College Management Committee (CMC), which shall be binding on all parties.

12. Applicability of Policies

- 12.1. These Fees and Scholarship Discount Policies are applicable only to students admitted during the academic year 2025-26.
- 12.2. The college reserves the right to revise these policies for subsequent academic years. Any changes or updates will be communicated to students and parents in advance.
